Liability and Responsibility in Legal History

XXVIth Annual Forum of Young Legal Historians Istanbul, (12 - 14 October 2022)



Our next gathering aims to investigate liability and responsibility through legal history. Such topic necessitates a multidisciplinary approach as legal liability concerns both civil law and criminal law and can arise from various areas of law, such as contracts, torts, taxes, or fines given by government agencies. Instead legal responsibility concerns legal obligation; a measure of mental capacity, used in deciding the extent to which a person can be held accountable for a crime (such as diminished responsibility); specific duties imposed upon persons to care or provide for others, such as the parents duty to the child or the guardianship of a ward; and a person's role in causing an event to happen. That is to say, a chain of causation means an individual is responsible for an event. This is actually part of the law of legal liability and public liability.

By analyzing these topics through a historical point of view, we can understand how the development happened and at the end we might answer the question of "why did it happen". For instance, the general principle in Roman legal thought was that there should be no liability for others: Gaius writes that "our condition can be made better but not worse through our slaves"; a fortiori, it could not be made worse by those who were not members of the family.

Further, in legal history, it is important to understand the interactions between these two terms (liability and responsibility) and their differences. Both terms might be interlinked but as to their consequences and their application there appear a difference.

We believe that the conference gives young legal historians a unique opportunity to present their research in the field and to get acquainted with the interdisciplinary approaches presented by their colleagues from around the world.

If you would like to present a paper during the conference, please send an application including an abstract of not more than 250 words and your CV to istanbul2022@aylh.org before 31st of January. Presentations have to be in English and should not exceed 20 minutes each. Presentation in Turkish language will be allowed together with simultaneous translator. The conference fee will be € 150, - and does not include travel and accommodation.

Criminality : Terminology and Interpretation

Editors: Angelika Herucová and Blanka Szeghyová

The primary aim of the issue is to examine the conceptualisation and definition of crime and forms of criminal behaviour and their interpretation in the medieval and early modern period. Categories and boundaries of what was considered criminal depended not only on circumstances determined by power and religion, but would change over the time together with the language usage. Papers should focus on definitions, development and interpretation of such labels that can be found in an array of historical sources including legal and official documents such as law codes and judicial records, but also in various narrative sources, moral and philosophical treatises and private documents that refer to criminal, illicit or sinful acts, offences against the law and morality. Historical perspective, interpretation of legal nomenclature and case law terminology are the basis of any further research. Both theoretical and case studies dealing with the following areas are welcome:

- denoting criminal behavior in historical sources and its interpretations
- laws, legal and court records terminology, shifts in the language use and comparison of terms
- transformations of individual types of offenses and their interpretations
- defining crime and criminal behavior – ideas, concepts and authors
- religious aspect of criminality, crime as a sin
- criminalization and decriminalization of acts and forms of behaviour and their social consequences
- the theories of crime in philosophical and legal treatises, their influence and application in practice
