which takes place on 14th and 15th June 2018

On the occasion of 100th anniversary of the establishment of the Czechoslovakia and other important constitutional anniversaries we are preparing an international conference, by which we want to refer with dignity to the state legacy of the Czech lands. The conference is held interdisciplinary. Among legal historians and lawyers who deal especially with constitutional law and theory of state and who will certainly create the very core of the performances we will also welcome participation of lawyers engaged in other legal branches, historians, archivists, archaeologists and other experts who are devoted in their scientific research to issues related to the state and legal evolution from its very beginning to present days. With regards to the significance of this anniversary the conference is also designed as a social event.

The following frames of thematic areas are assumed to be performed:

- 1) Sovereignty, state and statehood in the Central Europe
- 2) Continuation and discontinuation of state and law in the middle-European development.
- 3) Constitutional development of Czech lands in middle-European context
- 4) Development of constitutions and constitutional charters
- 5) Development of the position of the head of state

- 6) State symbolism and its manifestations in material culture
- 7) Legal position of national and ethnic minorities and its development
- 8) Material and legal instruments for the purpose of securing the state
- 9) Regions and their role in the genesis of state bodies
- 10) The structures of powers on our territory. Their form, development and reflection in historical and archaeological sources
- 11) Reflection of power and military conflicts in historical and archaeological sources from the beginning of the statehood to the present

The conference will last two days, where, apart from the conference itself, also cultural-social programme is on the schedule. Expected time of each performance is ca 15 minutes. A yearbook including the coming-outs from the conference will be the scientific output with lasting value, which will remind the important anniversaries of the Czech statehood.
