# **THE CONSTITUTIONS IN HISTORY**

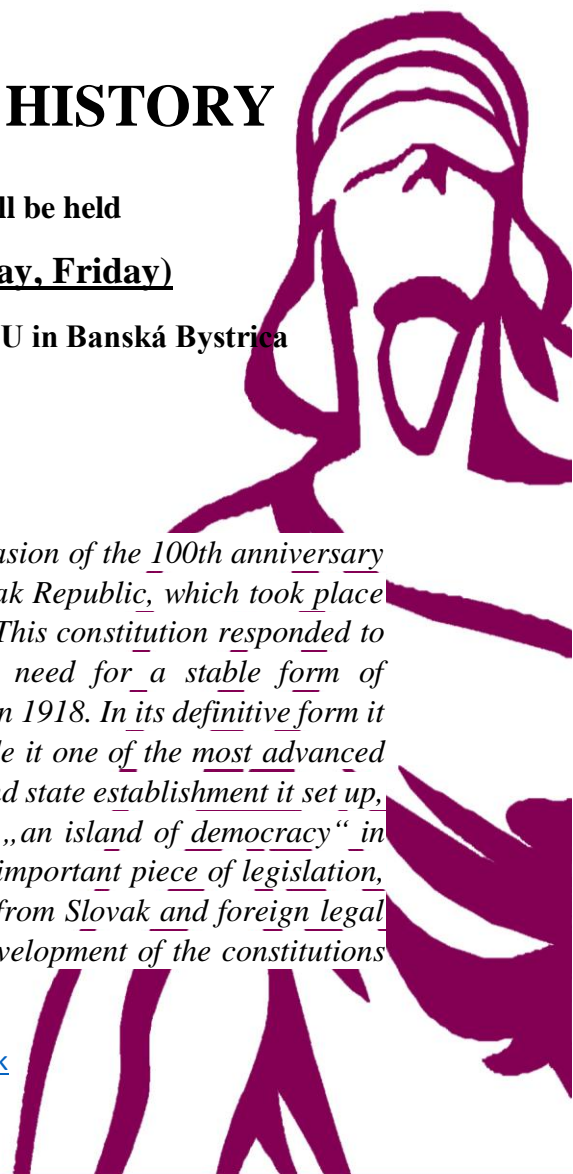

## **SCOPE OF THE CONFERENCE:**

*The International Scientific Conference is organized on the occasion of the 100th anniversary of the adoption of the Constitutional Charter of the Czechoslovak Republic, which took place on 29 February 1920 as Constitutional Act no. 121/1920 Coll. This constitution responded to the shortcomings of the temporary constitution and to the need for a stable form of administration of the Czechoslovak state after its establishment in 1918. In its definitive form it enshrined a number of positive democratic provisions that made it one of the most advanced constitutions of the time. Thanks to constitution and the social and state establishment it set up, the Czechoslovak Republic was at the same time described as „an island of democracy“ in Central Europe. In order to commemorate the adoption of this important piece of legislation, the organizers of the conference will be grateful to colleagues from Slovak and foreign legal faculties for presentations on topics related to the historical development of the constitutions*





*from the earliest times to the present, with questions of power and responsibility, power-sharing, checks and balances, principles of modern constitutionalism, with questions of interpretation of law, respectively, the influence of the constitutions on the interpretation of the norms of various branches of law, especially in the historical context. Contributions to socialist law and socialist constitutions, and in this context to changes in legal regimes, are also welcome. Also expected are topics related to the widest range of legal sciences, which are connected with the legal-historical, legal-theoretical, propaedeutic or positive-legal aspects of the constitutional law not only related to the law of the Slovak Republic, the Czech Republic, but also the constitutional law of other countries.*

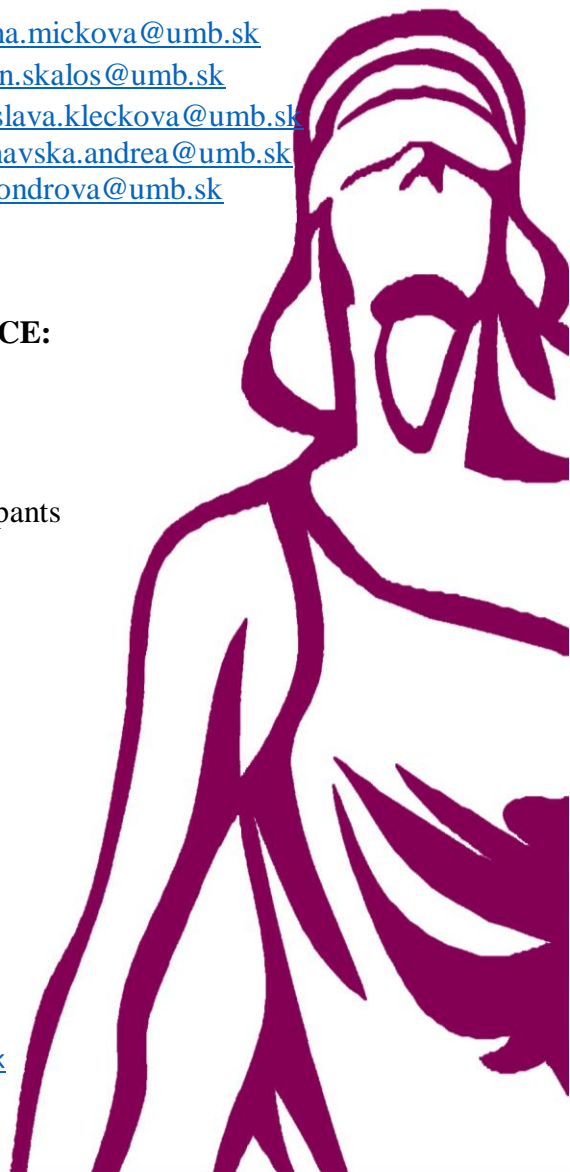

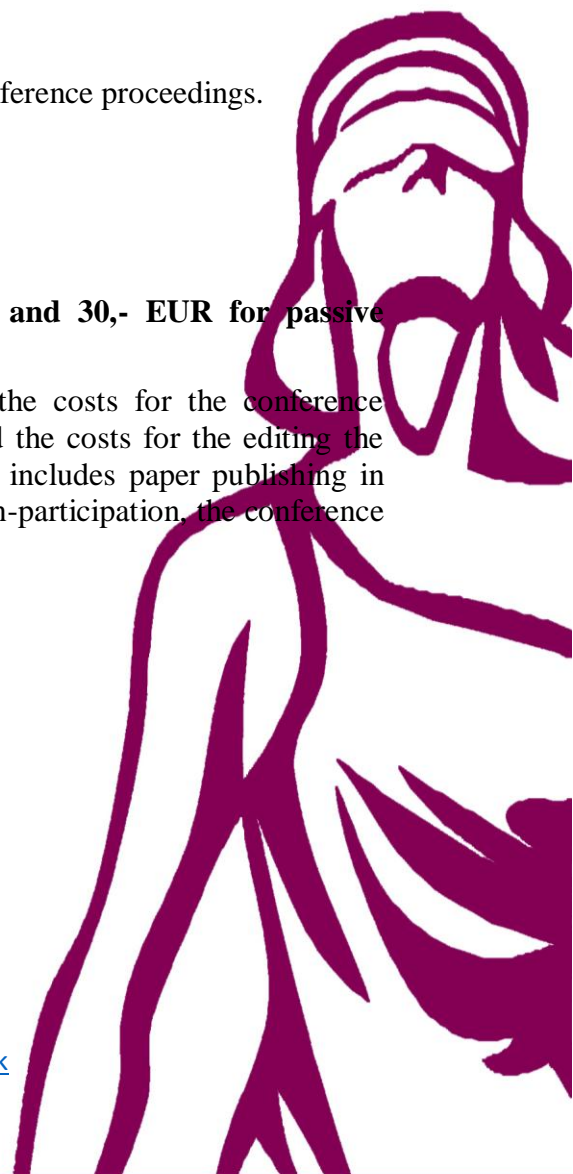
